<p align="center"><b>Documents to be Notarised Coloured Scans for Student Visa Lodgement</b></p>	<p align="center"><b>Original Documents that do NOT need to Notarised for Student Visa Lodgement, but should be presented in Coloured Scans</b></p>	<p align="center"><b>Original Documents to be presented in Coloured Scans that need to Bank Certified for Student Visa Lodgement Purposes</b></p>
<ul style="list-style-type: none"> <li>• Notarised coloured scan of all pages of passport – student and student dependent/s</li> <li>• Notarised coloured scan of all academic documents and work experience of the applicant and their spouse</li> <li>• Notarised coloured scan of appropriate English Language Proficiency Certificate such as IELTS, TOEFL, CAE or PTE Academic test result, etc.</li> <li>• Notarised coloured scan of Marriage Certificate and/or Children’s Birth Certificate/s (in English and local language), if relevant</li> <li>• Notarised coloured scan of Proof of Relationship between applicant and parents/sponsors – e.g. PAN card, AADHAR card, birth certificate, passport, official family tree</li> </ul>	<ul style="list-style-type: none"> <li>• Home Affairs Form 956A - Appointment or Withdrawal of an Authorised Recipient</li> <li>• Home Affairs Form 1281 - Australian Values Statement</li> <li>• Details of Applicant's Family Unit</li> <li>• Details of Applicant's Financial Sponsor's Family Unit</li> <li>• Marriage ceremonial photographs, if relevant</li> <li>• Affidavit Style Financial Sponsorship Declaration/s presented on Original in a Stamp Paper</li> <li>• SOP – GS &amp; GTE Profile</li> <li>• All evidence of acceptable Annual Income of financial sponsor/s to be shown for student visa purposes (e.g. annual salary and/or annual business, pension, agricultural and/or rental income, etc.) including ITR Form 16 documents for the last 2 years</li> </ul>	<ul style="list-style-type: none"> <li>• All evidence of Lump Sum Money Deposits and/or Sanctioned Education Bank Loan (which must state the size of the monthly loan repayments) to be shown by financial sponsor/s for student visa purposes (e.g. bank balance certificates, fixed deposit receipts and/or education loan agreements, etc.) including the following Education Loan related documents:             <ol style="list-style-type: none"> <li>1. Loan Disbursement Letter and Loan Account Statement - Original</li> <li>2. Property Ownership Deed and/or Property Valuation Report held by bank as a collateral</li> </ol> </li> </ul>
